7. Discuss and consider the status of the following projects and taking of any action in conjunction therewith – **Engineer Greg Phipps**

City Paving Improvements

Section 2

After discussion with the contractor and Geotech Engineering and Testing Inc, Engineer Phipps is recommending the pavement areas that are raveling and/or experiencing aggregate desegregation be seal coated. With the approval of Council, the areas will be marked and sealed.

Areas that have base failures, including Brutus, are being reviewed for repair requirements and estimated costs.

Council Member Lori Koepsel made a motion to give City Engineer Greg Phipps authority to mark and have these areas seal coated by Hayden Paving, Council Member James Brooks seconded the motion. Votes in favor: Unanimous

Section 4, Phase 1

AAA Asphalt, Inc. has submitted Pay Application No. 4 – Final amount of \$84,522.11, all retainage is being paid with this invoice. Total work to date is \$845,221.07.

Final inspection was completed on August 31, 2021, and Substantial Completion letter is attached.

Recommend approving pay application for payment.

Council Member Lori Koepsel made a motion to approve Final Pay Application No. 4 in the amount of \$84,522.11 to AAA Asphalt,Inc., Council Member David Mullane seconded the motion. Votes in favor: Unanimous

In accordance with general practice of pavement acceptance by local government agencies, including Montgomery County, Engineer Phipps suggests Council consider requiring Southern Oaks provide a road bond in the amount of one-half the cost of construction. After a period of one year from the date Council accepts the engineer's Letter of Substantial Completion, an inspection of the roads will be held with city personnel, engineer, developer and contractor. Any deficiencies found at that time will be rectified by Southern Oaks and a Letter of Final Completion will be presented to Council for consideration and acceptance. The bond will remain in-place until Council accepts the roadway into city maintenance. AAA Asphalt, Inc., will be responsible for failures due to workmanship and/or material provided under the pavement contact, in accordance with contract requirements.

City Drainage Improvements

The 90 days from the date of the bid opening to award the Shrek Pond Outfall Project has elapsed. Engineer Phipps suggests the project be tabled until funding can be found.
